

# **Hasbrouck Heights Public Schools**

## **OPEN CAMPUS LUNCH CONTRACT and INDEMNIFICATION AGREEMENT**

I, the parent/legal guardian, of the student named below, grant permission for my child to leave school premises for lunch for the 2020-2021 school year.

I understand that this is a privilege only for 6<sup>th</sup> through 12<sup>th</sup> graders. I understand that this contract must be signed by both me and my child. I understand that only students with signed contracts will be allowed this privilege.

My child agrees to abide by the terms and conditions of this contract. My child and I understand that if my child violates the terms and conditions of this contract that his/her privilege will be revoked, and he/she will be subject to discipline.

I understand that I am responsible for my child and his/her actions when he/she leaves the school building and/or school grounds. I understand and accept that neither the Hasbrouck Heights Board of Education (“Board” or “District”) nor its board members, agents, servants, or employees will in any way monitor and/or control my child’s whereabouts or safety, or be responsible for my child’s acts or omissions, while my child is away from his/her school building and school grounds. I understand that the Board is not responsible for the supervision of any student while that student is off campus. I understand that the Board assumes no responsibility for any injury that may occur while my child is off campus.

My child must return to his/her District school building for the remainder of the school day after lunch. If my child becomes ill during lunch, I must immediately notify the attendance office that my child will be absent for the remainder of the day. My child must present a note from me upon his/her return to school.

My child must not be tardy for any class following his/her lunch period. Cumulative tardies (4) will result in my child’s suspension of this privilege. Truancy by my child to any class at any time of the day may result in revocation of this privilege.

My child will not loiter on District property, District parking lots, or surrounding area/neighborhood.

The District administrators reserve the right to revoke the privilege for all 6<sup>th</sup> through 12<sup>th</sup> grade students. This privilege is restricted to the 2020-2021 school year. This is not precedent setting.

My child and I have read this contract and agree to abide by the terms and conditions set forth for this privilege.

I hereby agree to waive and relinquish, fully release and discharge, defend, indemnify, and hold harmless the Hasbrouck Heights Board of Education and/or its current and future board members, agents, servants, employees or other representatives, individually or otherwise, from any and all liabilities, claims, physical injury, bodily injury, damages, losses and expenses, including reasonable attorneys' fees, that may arise out of and/or in connection with my child's departure from his/her school building and/or school grounds in connection with my child's open lunch period. This indemnification agreement's scope of coverage shall include, but not be limited to, bodily injuries suffered by my child, other students, Board employees and/or any other persons.

I further agree to waive and relinquish, fully release and discharge, defend, indemnify and hold harmless the Hasbrouck Heights Board of Education and/or its current and future board members, agents, servants, employees or other representatives, individually or otherwise, against any and all claims initiated by anyone on behalf of my child or by my child upon reaching the age of majority, for injuries, damage or loss which may occur to my child, including, but not limited to, injury, disability, or death, as a result of leaving campus during their lunch period.
