3. Able to read and write
4. A resident of the Municipality from which he/she is to be elected for at least one year preceding the date of the Election
5. Not disqualified as a voter pursuant to *N.J.S.A. 19:4-1, 18a:12-1**
6. A registered voter in the Municipality they are running
7. Must provide a functioning email address
