Re: Kindergarten Registration for 2024-2025 School Year

Dear Hasbrouck Heights Resident,

Kindergarten registration for the 2024-2025SY will begin on **Wednesday, January 24, 2024 at both Euclid and Lincoln Elementary Schools. Please call the school secretary based upon your residence (Kipp Avenue and north – Lincoln School; Jefferson Avenue and south – Euclid School) to set up an appointment to bring in your registration forms and documents. Lincoln School – 201-393-8182; Euclid School – 201-393-8176).**

The Kindergarten program is a full-day, 8:20 am until 3:03 pm. This program is only for students who are 5 years old on or before October 1, 2024. A before- and after-school program (KEYS) will be available at an additional cost. Information about KEYS will be emailed to you over the summer, after you register your child in the district.

To complete registration, you must download documents from the district website (<http://hhschools.org>) and bring the completed forms with you to registration:

1. A completed District Registration Form;
2. Student Information Form;
3. Home Language Survey;
4. A Physical Examination Form, dated and signed by a medical provider;
(The medical provider's office must stamp the form giving its name, address and phone number.)
5. An Immunization Form*, *with signature of the physician*;
6. A Dental Exam Report Form, with the date, dentist's name and signature;
7. A Health Assessment Medical History Form;
8. An Authorization for Sharing Information Form

If your child has any medication requirements or conditions such as allergies the following two forms are also needed:

1. A Physician's Request to Administer Medication Form;
2. An Authorization for Sharing Information Form.

** Evidence of Mantoux tuberculin skin testing within the past 6 months for students entering the school system for the first time, if born in a high TB incidence country*

The following original documents (along with a photo copy of each) must also be brought to registration:

Proof of Residency: Property tax bill, deed, contract of sale, mortgage, lease, or a signed and notarized letter from landlord (we ask that the student's name appear on the lease or signed letter from landlord);

4 of the Following Proofs of 'Attachment to Address': Voter registrations, licenses, permits, financial account information, utility bills, delivery receipts, and/or other evidence of attachment to the given address. **We cannot accept computer generated forms, only proofs received through the mail.**

Student Information:

1. Birth Certificate;
2. Immunization Record;
3. Proof of Physical Exam;
4. Proof of Dental Exam;
5. Name and address of previous school (if applicable);
6. Most recent school report card (if applicable).

Please note in advance that we are not permitted to process a registration without all of the documentation as stated above. **Finally, placement at Euclid or Lincoln School will be determined by multiple criteria and will not be finalized until August 2024.**
