

**HASBROUCK HEIGHTS BOARD OF EDUCATION
SPECIAL MEETING MINUTES
THURSDAY, JUNE 9, 2022**

A regular meeting of the Board of Education was held on Thursday, June 9, 2022, in the High School Auditorium, 365 Boulevard, Hasbrouck Heights, New Jersey. The meeting was called to order at 7:00 p.m. by Board President, Mrs. Ferdinand.

Mrs. Ferdinand read the following statement:

The New Jersey Open Public Meeting Law was enacted to insure the right of the public to have advance notice of and to attend the meetings of public bodies at which business affecting their interest is discussed or acted upon.

Pursuant to the New Jersey Open Public Meeting Act, Public Law 1975, Chapter 231, the Board Secretary caused notices of this meeting to be given to the public and the press on June 1, 2022.

Said notice was posted at the Hasbrouck Heights Municipal Building, Hasbrouck Heights Board of Education Office, Hasbrouck Heights Middle and High School, Euclid Elementary School, Lincoln Elementary School, and Hasbrouck Heights School District Website.

Notice of said meeting was published under legal notice in The Record.

Mrs. Ferdinand led the Board in the flag salute.

Mrs. Ferdinand made the following statement:

Before we start this meeting, I want to remind everyone here that the members of this board of education are volunteers. We do not get paid for this, we all do this because of our love for this town, this district, our children, and YOUR children.

We are all parents and have kids here, or some of our children have already graduated and are out in the world as successful individuals.

I have been on this board for 4.5 years and while the past 2 years have been difficult for all of us, it's been the most challenging for me as a board member and many difficult decisions have had to be made.

The amount of hours that I have given back to our district is more than you can even imagine. The past few months have been difficult and the amount of disrespect I have felt from my fellow community members is shocking. While I am empathetic for how upset you all are over different situations, I feel it's necessary to show my continued support and respect for myself, my fellow board members, and the district we represent.

We are volunteers, we choose to do this job and show up for all of our kids. This job isn't easy and you all have the same opportunity to run for a seat here at the table.

Please choose to show us kindness and respect. Our children are watching the behaviors of all of us.

As for everyone employed by this district...they also deserve kindness and respect, they are the ones with our children everyday developing their minds and shaping their futures. When speaking, please make sure your statements and concerns are reflective of that. Thank you.

Dr. Helfant stated: There has been a lot of conjecture about the transfer. There have been verbal discussions over past two years with Mr. Mastropietro where he has indicated his desire, both professional and personal, to be an elementary principal if the opportunity arose. When Mr. Sickels applied for the Director of Special Services position, a possible opening at Euclid school could occur. Mr. Mastropietro submitted a letter to myself and the board president requesting a transfer. Mr. Mastropietro rescinded his request right before the May meeting, leaving insufficient time for the board to discuss per district policy.
