Work Session Meeting Minutes

A work session meeting of the Board of Education was on Thursday, March 23, 2023 in the Hasbrouck Heights Board of Education Conference Room, 379 Boulevard, Hasbrouck Heights, New Jersey. The meeting was called to order at 6:04 p.m. by Board President Mrs. Cintron.
