WHEREAS, the Hasbrouck Heights Board of Education appropriated \$6,000 for travel during the 2018-2019 school year and has spent \$1,102.77 as of March 12, 2019.

NOW, THEREFORE BE IT RESOLVED that the Hasbrouck Heights Board of Education hereby establishes the school district travel maximum for the 2019-2020 school year at the sum of \$6,000 and
