- The Board discussed home schooling issue and creating a policy to address home schooling.
- 3. Dr. Porto reported that the state said we have to resubmit the violence and vandalism report to accurately reflect the incidences. We originally reported 59 and the number decreased to 46.
- 4. Dr. Porto reported the district's QSAC results. We have been deemed a "High Performing District". We received 100% in three areas, 84% in governance and 88% in instruction. We received an 88% in instruction for the following: Language Arts in 3rd, 5th, and 8th did not meet the state benchmarks; our curriculum has not been updated since 2004; and the current gifted and talented program is considered an enrichment program it must come from the curriculum and will be revamped for the 13-14 school year.
- 5. Dr. Porto reported that NJ Monthly published its annual Best High Schools and HH has increased from 107 to 72.
- 6. The staff will be trained on November 6th for the new teacher evaluation system.
- 7. Tests results will be given out in October. The 3rd and 4th grade scores were poor in many districts. The word is that the state may possibly throw out the test for those grades.

- 8. Dr. Porto reviewed items that we should budget for the 13-14 school year.
- 9. Discussed the sports co-op with Wood-Ridge.
- 10. Discussed advertising signs for the field.
