

STANDING ORDERS FOR FIRST AID

Before instituting any treatment, a patient should be asked about any known allergies or current medications or medical conditions.

Abscesses

A collection of pus in a specific area as a result of infection.

NOTE: tenderness and pain in area. Contact parent, warm soak if appropriate or cover with dry sterile dressing.

Abdominal Discomfort

May go to bathroom, lay down for 10-20 minutes. If not relieved contact the parent.

Dysmenorrhea

Menstrual discomfort or pain. General lower quadrant discomfort or cramps. May lie down for 10 to 20 minutes for relief. If not relieved after 20 minutes contact parent.

Abdominal Pain

Pupils should be placed under care of parents with the following advice:

Do not give food or drink

Not to give medication, particularly a laxative until they have contacted family health care provider.

If pain persists contact health care provider

*NOTE: Any pupil who reports to the nurse frequently with repeated abdominal complaints should be requested to visit their family physician and have the school advised of any recommendations.

Accidents-Injuries

All accidents which occur in school, an accident report is to be completed. Depending on the nature of the accident First Aid procedures should be followed.

Allergic Reactions

1. Insect Bites/ Stings: See procedure

2. Hives: Smooth elevated pinkish patches (wheals) which suddenly develop on skin. NOTE: Vary in size usually white center, are irregular in shape, intense burning or itching at site. Remove contact if recognized. May apply calamine. Advice parent to seek medical attention if not relieved.

Asphyxiation

Stoppage of breathing (Apnea). Check for foreign body obstructing airway and eliminate if possible (Heimlich). Start rescue breathing. Send for medical assistance. Contact parent. Notify Principal.

Asthmatic attacks

Labored breathing, coughing or wheezing. Reassure pupil give rescue medication if ordered, Make pupil as comfortable as possible. Sit tripod position. Contact parent and emergency service if no relief from rescue med as comfort measures, notify principal. KEEP NEBULIZER IN NURSE'S OFFICE

Athletes Feet

Fungus infection of the feet. (scaling of skin between toes, itching sensation and sometimes blistering between toes and soles of the feet) Advice good foot hygiene

Bee/Wasp/Hornet Stings

Remove stinger if present, apply Benadryl cream or 0.5% Hydrocortisone cream, then a sterile, dry dressing and cold pack. Pain and swelling will be present at the site. Notify parents and principal.

If there is a history of allergy, parent should be contacted and advised to seek medical attention. If anaphylactic reactions give epi pen as per order and call 911.

Bites (animal, human)

Wash wound with running water and soap then apply sterile dressing. Notify principal. Contact parent and request they seek medical advice from health care provider.

Report animal bites to the health department Human bites are reported if skin is broken Give as much history as possible Name and address of pupil

Kind of dog etc.

Description

Name and address of owner of animal if known

Bleeding

Follow universal precautions apply pressure directly to wound if possible or major pressure point next to wound. Apply sterile dressing contact parent and 911 if needed. Notify principal and parents. Observe for signs of shock.

Blisters

Apply a protective dressing. Do not puncture. If blister is already ruptured, wash with soap and water and apply dressing.

Boils

Reddened painful elevation on skin. A core may form is center. Apply sterile dressing. NOTE: If boil is broken cleanse area and apply dry sterile dressing. Notify Parents.

Splinter

Cleanse area. Remove visible splinter with forceps. If splinter can not be removed without breaking the skin, contact parent.

Sprain

Rest injured joint. Elevate and apply ice and wrap as needed. Contact parent if medical attention is needed.

Stings

See bee stings

Swallowed objects

Contact parent. Seek medical attention as needed. Notify principal.

Sty's

May apply warm soak for temporary relief. Contact parent advice medical treatment.

Throat (foreign body in)

Allow pupil to cough object up. Do not probe with fingers. Follow Heimlich maneuver guidelines. Seek emergency medical attention as needed. Contact parent. Notify principal.

Sore Throat

Determine extent. Allow Na gargle encourage fluids. If accompanied by elevated temperature. Contact parent and exclude pupil from school.

Ticks

Grasp as close as possible to skin using a tweezers. Pull strait out with a steady motion. Wash site thoroughly with soap and water. Apply first aide cream. Save tick. Contact parent. Advice medical attention.

Toothache

May rinse mouth with warm water. Contact parent to seek dental attention.

Wounds

TYPES OF WOUNDS

Abrasions- skin rubbed or scraped Incisions-cuts made with a sharp object Punctures- made by nails pencil points,ect

Abrasions Incisions and Lacerations

Control bleeding by applying pressure as necessary. Clean with soap and water. Apply first aide cream and dry dressing. Depending on severity, contact parent and seek medical attention.

Puncture

Apply above procedure. Inquire as to tetanus immunization status. Contact parent.

Seek medical attention as needed.

Headache

Try to ascertain: onset of symptoms

If pupil has eaten

Possibility of head injury

If any medications were taken.

Assess temperature. Pupil may lay down for 10 to 20 minutes with cool compress. If unrelieved contact parent. NOTE: Any pupil who reports to the nurse frequently with headaches, should be requested to seek medical attention and the school should be advised of diagnosis and treatment.

Heart Emergencies

Seek medical attention. Contact parent. Follow American Heart Association procedures.

Hives

See allergic reaction

Insect bites

See Bee Stings

Nausea

Rest for twenty minutes, if no relief contact parent.

Nasal Congestion

Contact parent. Symptoms of a cold should be treated at home

Nose (foreign body)

Do not attempt to remove unless freely movable. Contact parent. Seek medical attention. Notify Principal.

Poison Ivy (also Oak and Sumac)

May apply calamine lotion. If weeping cover with dry sterile dressing. Contact parents and notify principal.

Poisoning

Administer antidote recommended on container from which poison came (if available). Seek medical attention. CALL POISON CENTER AND FOLLOW DIRECTIONS GIVEN. IF POISON UNKNOWN SEND DIRECTLY TO THE HOSPITAL. Notify parent and principal.

Rashes

All suspicious rashes, where no allergy has been reported shall be considered a communicable disease until <u>medical diagnosis</u> and a note presented to school nurse with <u>specific noncontagious diagnosis</u>. Students are to be sent home until they have been medically cleared.

Shock

Lay pupil down with head lower than rest of the body (unless shock is a result of head injury) Keep pupil warm. Control any bleeding. Seek medical attention contact parent and principal.

Earache

Check temperature. Assess ear for redness or drainage. Contact parent if unrelieved by comfort measures.

Ear (foreign body in)

Contact parent. Advice medical attention. Notify principal...

Emesis

Contact parent. Exclude pupil. Pupil may return to school when symptom free for 24 hours.

Epitaxis

Apply pressure to nostrils. May apply ice to back of neck or nose. Release pressure gradually. Instruct pupil not to blow nose. Contact parent if severe. Any pupil who reports to the nurse frequently with repeated nose bleeds should be assessed by medical provider and recommendations given to school.

Eye Accidents

Foreign body in the Eye:

Eye wash or other appropriate solution may be used for irrigation. A cold pack may be applied to relieve irritation. If irritation persists and foreign body remains, cover with sterile dressing. Contact parent and principal.

Injuries to the Eye:

Cover the affected eye with a sterile eye pad over a closed eye and refer for immediate medical attention. Apply ice over the sterile dressing. Contact parents and principal.

Fainting

Lie pupil down with feet slightly elevated 30-45 degrees. Contact parent and inform principal. Monitor and document vital signs, level of consciousness, airway, breathing and circulation.

Fever

Exclude pupil if temperature 99.5 degrees. Must be fever free with out the use of any medication for 24 hours prior to returning to school.

Fracture (simple)

Symptoms:

Pain at site Tenderness Swelling Decreased range of motion

Booloadea range et meuer.

Immobilize-give supportive treatment- form splint or bandage-elevate if possible-apply ice. Contact parent. Seek medical attention inform principal.

Frostbite

Immerse affected part in WARM, not hot water. If on face, apply warm, moist compress. Do not rub affected part. Contact parents and principal.

Convulsions (epileptic and Non-epileptic)

Lay the person supine on the floor and turn head to one side. Assess and care for airway, breathing and circulation. Time and assess level of orientation after seizure. Remove objects on which the person might injury themselves. Do not restrain, keep person warm and quiet. Notify parent and principal and arrange immediate transportation.

Diabetic Emergencies (diabetic coma, ketoacidiosis, severe hyperglycemia)

Failure to take or produce enough insulin to meet the metabolic requirement. Pupil will require insulin. Seek medical attention. Contact parent and principal. Symptoms:

Pain in abdomen

Nausea Vomiting Drowsiness Dyspnea Flushed face

Fruity odor to breath

Hypoglycemia or insulin shock

Symptoms:

Sweating Shaking Rapid pulse Hunger Irritability Anxiety

Impaired vision

Fatigue

Convulsion and coma if untreated

Treatment-

provide high carbohydrate snack (juice, hard candy, milk).

Notify parent and principal

Retest glucose level in 15 minutes.

If convulsing or coma-give glucagons if ordered, call 911, notify

Principal and parent

Diarrhea

It may be necessary to exclude the pupil. Contact parent-pupil will be more comfortable at home.

Dislocation

Immobilize –give supportive treatment-form of splint or bandage. Apply ice. Contact parent and principal. Seek medical attention.

Dizziness

Assess neurological status. Question pupil regarding injury. If unrelieved after rest, contact parent and advice medical attention.

Burns

First-Degree (superficial) - Skin Reddened:

Rinse affected area thoroughly with cold running water. Cover with dry sterile dressing. Advice medical attention if needed.

Second-Degree (serious) - Skin Reddened and Blistered

Rinse affected area thoroughly with cold running water and apply sterile dressing. Cover with cold wet clean towels or sheets. Assess for signs of shock. Contact parent and principal. Seek immediate medical attention.

Extensive Second and Third Degree

Cover affected area with clean moist towels or sheets and arrange for immediate transportation to the hospital.

Contact parents and principal.

Chemical Burns

Immediately rinse affected area for at least 10 minutes with copious amounts of water. If antidote is known and available, apply to the affected area. Cover with sterile dressing.

Arrange immediately for further medical treatment.

Contact parent and principal.

Burns or Chemical Exposure of the Eye

Flush eye with water for at least 15 minutes using faucet, eyecup or eye wash bottle. Cover closed eye with sterile dressing and arrange for immediate transportation to the hospital.

Contact parents immediately and notify principal

Chills

Usually a prelude to fever, hence early sign of illness. Pupil may lie down and cover with blankets. Contact parent. Pupils with a temperature of 100 degrees should be excluded from school.

Colds

Instruct pupil and parents on infection control. Pupils with a temperature of 100 are excluded from school. Encourage fluids. Advice medical attention if necessary.

Concussions/ Head Injuries

All head injuries require immediate contact with the parent/guardian or emergency contact. All head injuries may be possible concussions. Contact parent and principal.

Symptoms:

Dazed or unconscious

Bleeding from mouth, nose or ears

Weak rapid pulse

Pupils unequal or poor response to light

Headache

Dizziness

Possible nausea or vomiting

RESOLUTION ELIMINATING THE POSITION OF TREASURER OF SCHOOL MONEYS

WHEREAS, the School Business Administrator possesses the proper cer qualifications to assume the duties of the treasurer of school moneys	tifications and
NOW, THEREFORE, BE IT RESOLVED, BY THE <u>Hasbrouck He</u> OF EDUCATION IN THE COUNTY OF MONMOUTH, AS FOLLOW	

- 1. The school business administrator shall receive, deposit, and hold in trust all school moneys belonging to the district from whatever source derived free of any control by the governing body of any municipality comprised in the district.
- 2. The school business administrator shall deposit the school moneys or such part thereof as may be designated in any bank or banking institution of this State designated by it as a depository of school moneys, which may include the State of New Jersey Cash Management Fund, MBIA Cash Management Fund and NJARM Cash Management Fund.
- 3. The school business administrator shall, upon depositing the same therein, be relieved from liability for any loss thereof which may be caused by reason of the deposit.
- 4. The school business administrator shall be bonded in such amount and with such surety as the board shall direct.
- 5. The school business administrator shall keep a record of the sums received and paid out by him/her in accordance with the uniform system of bookkeeping prescribed by the State Board.
- 6. The school business administrator shall upon ceasing to hold the office of school business administrator, pay over the balance of school funds remaining in his/her hands to his/her successor in office.
- 7. The school business administrator shall comply with all provisions of the law.
