Report of the Board President -

Mrs. Ciocia thanked the students who assisted at Back to School Night, orientation, and open houses.

Mrs. Ciocia also reported that she will be attending the School Board convention in October and will attend the presentation in which Ms. Dubofsky will be honored.

Mrs. Ciocia stated that she was able to greet all of the new teachers as well as the rest of the staff on the first day the staff reported, September 4th. She wishes everyone a happy and successful school year!

Report of the Student Representatives-

K. Garden gave the update on the Middle School. She reported on the success of Back to School Night and new student orientation. She also reported on the various activities that will be taking place in the middle school.

C. Ocampo gave the update on the High School. He reported on the success of Back to School Night and new student orientation. He also stated that on the first day of school, the HIB was discussed by all teachers. He also stated that students are currently enrolling in the dual enrollment courses.

Report of the Superintendent -

Dr. Porto stated that summer assignments are displayed around the library. He is currently working with the principals to change how we assign the summer work.

Dr. Porto stated that the calendar for school year 2012-2013 has to change due to graduation. In order to accomplish that, a single session day has been added on October 8th. Dr. Porto stated that he will mail a letter to all parents explaining the need for the change.

Dr. Porto discussed the state mandated new principal/teacher evaluation process. Student test scores will now tie into a teacher's evaluation. A district advisory group has been formed and the district has chosen the Charlotte Danielson Evaluation technique. All teachers must be trained with 15 hours of professional development. In order to accomplish this, single session days have been added to the school calendar for 12-13.

Dr. Porto also discussed the dramatic enrollment growth the district is experiencing and how we are using our facilities to their fullest extent to create smaller class sizes.
