A regular meeting of the Board of Education was held on Thursday, October 21, 2010, in the Middle/High School library, 365 Boulevard, Hasbrouck Heights, New Jersey. The meeting was called to order at 8:04 p.m. by President, Mr. Giarratana.

<u>Correspondence/Report of School Business Administrator/Board Secretary</u> – Auditors are currently in the process of completing our audit for 2009-2010; the roofers are currently in the process of completing the metal capping on the MS/HS roof; we are currently in the process of completing the ASSA report, DRTRS report and the Debt Service report. To date, we have submitted to the state for 75% of reimbursement for the construction projects.

Report of the Board President – Mr. Giarratana reported the results of the uniform survey. We had approximately 800 parents respond with 526 in favor of uniforms and 272 opposed. We had approximately 150 staff members respond with 105 in favor of uniforms and 43 opposed. We are going to set up a Uniform Committee with the members including the Business Administrator, two parents, two staff members, and two teachers. The parents and staff members will be selected from the people who voted through a lottery system. We will have the committee selected by November.

<u>Report of the Student Representatives</u> – A. D reported on the happenings at the High School and Euclid School and C.G. reported on the events occurring at the Middle School and Lincoln School.

Report of the Superintendent – Dr. Porto presented his Reform Plan for the Middle/High School for School Year 11/12. He will be showing the presentation to students on November 1<sup>st</sup>. The power point presentation is available for viewing on the district's website. Dr. Porto also wanted to clarify what he means by all Heights Students attending "college". College is defined as any post- secondary education which includes 3,6,9,etc., month certification courses, the military, 2-4 year colleges.
