**Special Meeting Minutes**

A special meeting of the Board of Education was held on Thursday, June 3, 2021, in the High School Media Center, 365 Boulevard, Hasbrouck Heights, New Jersey and remotely through the use of electronic equipment. The meeting was called to order at 6:30 p.m. by Board President Mrs. Ferdinand.
